

Privacy Notice in Accordance with Article 13 EU GDPR (Information to be provided where personal data are collected from the data subject)

As part of the Bundeswehr Education and Training Convention 2024, Helmut Schmidt University/University of the Federal Armed Forces Hamburg (HSU/UniBw H) will collect and process your personal data. In the interest of transparency regarding data processing and your rights and in order to meet our obligations in accordance with Article 13 of the GDPR, we would like to provide you with the following information.

3. Purposes of personal data processing

Personal data will be processed as part of the Bundeswehr Education and Training Convention as well as for the subsequent documentation and public relations work.

4. Legal basis for data processing

Data will be collected on the basis of your consent (Art. 6 (1) (a), (7) GDPR). For the documentation of the event and for public relations purposes, data will be processed pursuant to Art. 6 (1) (e), (3) (b) GDPR in conjunction with Section 3 of the Federal Data Protection Act.

5. Recipients or categories of recipients of the personal data

For access to the premises of Helmut Schmidt University/University of the Federal Armed Forces Hamburg, the following personal data will be sent to the support personnel of the barracks commander: Last name, first name, company / institution.

For the processing of invoices, your data will be transmitted to the central administration office (Section II 1 -Budget).

We will publish high-profile photographs and video footage on our web pages and social media channels as well as in the press.

6. Transfer of personal data to third countries or international organizations

Personal data is not transferred to third countries or international organizations and there are no plans to do so in future.

7. Retention period

The convention registration data will be deleted by 31 December 2024.

On account of tax and budgetary recording and retention policies, invoicing data are subject to a ten-year retention period. If you have provided your consent, photographs and video footage can be used for an unlimited period of time.

8. Data subject rights

With regard to personal data relating to you, you may exercise the following rights against the controller:

- Right of access by the data subject pursuant to Art. 15 GDPR,
- Right to rectification pursuant to Art. 16 GDPR,
- Right to erasure pursuant to Art. 17 GDPR,
- Right to restriction of processing pursuant to Art. 18 GDPR,
- Right to data portability pursuant to Art. 20 GDPR,
- Right to object pursuant to Art. 21 GDPR,

In addition, you have the right to lodge a complaint with a supervisory authority (Art. 77 GDPR). The supervisory authority in Germany is the Federal Commissioner for Data Protection and Freedom of Information, Graurheindorfer Straße 153, 53117 Bonn.

9. Right to withdraw consent

Where data are processed based on (implied) consent the data subject has the right to withdraw his or her consent at any time with regard to future data processing. The withdrawal of consent will not affect the lawfulness of data processing based on consent before its withdrawal.

10. Obligation to provide personal data and consequences of failure to provide it

If you attend the event in person, you are not obliged to appear on camera unless it is absolutely necessary for the type of event that the attendees be seen online by the virtual participants. If you participate online, the same applies to the use of your camera. You are not obliged to accept or to consent to your image and/or voice being recorded.

11. Automated decision-making

Automated decision-making will not take place.

Information on visual and audio recording during the event

During the Bundeswehr Education and Training Convention, photos and videos will be taken. As part of reporting on the convention, we will publish this material on our web pages, in social media and in the press in order to inform a large audience about this event.

By voluntarily attending the event you accept random photos and videos being taken and published. If you wish not to be photographed/filmed or if you do not agree with the photos/videos being published, please inform our staff during the event.

If pictures are taken of individual persons (e.g. group photos, interviews or similar), their consent to these pictures (photos/videos) and the processing and use of these pictures is necessary. In this case, you will receive additional information and we will ask for your consent.
